This abattoir must at all times comply with the requirements laid down in the Meat Safety Act 2000 (Act No. 40 of 2000). This certificate is not transferable and lapses if for any reason whatsoever ownership of the abattoir changes and/or the abattoir does not comply with the conditions of issue.

Conditions of issue:

- The maximum daily throughput of this abattoir **may not exceed 390 000 units**, without the prior written consent of the Mpumalanga PEO. "unit" in relation to a quantity standard for determining throughput for poultry, means - (i) one chicken; (ii) one turkey or (iii) one duck.
- Essential National Standards as prescribed by section 11 of the Act and other relevant sections of the Act to be complied with at all times.
- All prescribed structural and other required changes to be made within the prescribed period.
- The Hygiene Assessment System (HAS) to be completed by the responsible meat inspection staff at the abattoir and to be verified by a Provincial Veterinary Public Health officer on a quarterly basis.
- Schedule 8 or 9 monthly returns to be submitted on a monthly basis. (As applicable.)
- A detailed waste disposal system including condemned material and effluents to be in place.
- **The validity of this certificate commences on 2022-04-01 and expires on 2023-03-31.**
