- This certificate is not transferable and lapses if for any reason whatsoever ownership of the abattoir changes,
- This abattoir must at all times comply with the requirements of the Meat Safety Act, 2000 (Act 40 of 2000) and the Poultry Regulations R 153 of 24th February 2006.
- 3. Only poultry may be slaughtered at this abattoir and these animals must always be handled humanely during transport, off-loading, lairaging, stunning and bleeding per the requirements of the Meat Safety Act, 2000 (Act 40 of 2000) and the Animal Protection Act, 1962 (Act 71 of 1962).
- 4. Bird for bird meat inspection must be done by qualified and registered inspectorate and the minimum meat inspectorate on duty during production must be at least 2 Poultry Meat Inspector(s), 1 Poultry Meat Examiner(s) level two and 10 Poultry Meat Examiners Level one. the veterinarian must be present at the farm of supply.
- The maximum daily throughput may not exceed the following units per day without the prior written consent of the Provincial Executive Officer:

- 3. The attached original registration certificate must at all times be available at the abattoir for audit and verification purposes.
- 4. This certificate may in terms of section 9 of the Act be withdrawn by the Chief Director if she is convinced that you have failed to comply with the conditions under which this certificate was issued, or if the abattoir does not comply with the prescribed requirements of the Act.
- 5. Your abattoir must be managed in such a manner that a safe, sound and wholesome product is always produced. Your attention is also drawn to the contents of the regulations R 1072 dated 17th September 2004 which requires every owner/superintendent to provide himself with a copy of the Act and the applicable regulations promulgated there under.
- It is compulsory that abattoirs comply to the requirements set out in the Meat Inspection Scheme (section 4) established under section 12 of the Meat Safety Act, 2000 (Act 40 of 2000).
